**MOTION TO TERMINATE THE CHILD SUPPORT OBLIGATION OF JOHN
DOE AND MOTION TO SET CHILD SUPPORT AGAINST JANE DOE**

NOW INTO COURT, comes **JOHN DOE**, petitioner in rule, and respectfully requests that this Honorable Court terminate his child support obligation for the following reasons to wit:

1.

That pursuant to a Judgment of this Honorable Court rendered on January 10, 2000 **JOHN DOE** was ordered by this Honorable Court to pay child support to **JANE DOE** in support of their minor children in the amount of FIVE HUNDRED AND NO/100 DOLLARS (\$500.00) per month.

2.

That **JANE DOE** no longer has physical custody of the minor children, and that **JOHN DOE** has had physical custody of the minor child since June 1, 2004.

As a result, **JOHN DOE** has been supporting the minor child, while the child is in his physical custody and is entitled to have the child support obligation payable to **JANE DOE** terminated.

Defendant in Rule, **JANE DOE**, is employed and petitioner is in need for the support of the minor children, and desires that defendant should be ordered to show cause why there should not be judgment in favor of petitioner and against defendant ordering defendant to pay petitioner a reasonable amount as child support for the minor child to be fixed by this Court under the provisions of La. R.S. 9:315 et. Seq.

WHEREFORE, mover prays that the defendant be ordered to show cause on a date and time scheduled by this Honorable Court why the defendant in rule should not

pay petitioner a reasonable amount as child support for the minor children to be fixed by this Court under the provisions of La. R.S. 9:315 et. seq. and why the petitioner-in-rule's child support obligation should not be terminated.
